

Revised Notice

(For the Homebuyers in whose cases Refunds have been approved by the Hon'ble Supreme Court vide its Order dated 13.10.2022)

1. List of Homebuyers to whom refunds have been allowed:

It is hereby notified for the information of all such Homebuyers to whom the refunds have been approved by the Hon'ble Supreme Court on grounds of Medical Exigencies vide its order dated 13.10.2022. The List of the concerned homebuyers is hereby uploaded on the website for the information of all concerned.

2. Procedure to be followed by the concerned Homebuyers:

The following procedure shall be followed for making the said refunds:

- (i) The Homebuyers are called upon to submit the following documents, both in electronic mode on the dedicated email homebuyers.medicalexigency@unitechgroup.com and in physical mode at the Corporate Office of Unitech Limited, addressed to Sh. S. R. Tiwari, Senior Executive, Commercial Division (Mob. 9871304835), Tower-B, Signature Towers, 13th Floor, South City-I, Gurugram-122007, latest by 31.10.2022. Submission of the required documents in electronic mode would enable the Management to immediately start processing the cases for refund in parallel by the time the physical copies of the documents are received in the Company.
- (ii) A total of 90 Homebuyers have submitted the documents in electronic mode and 74 Homebuyers have submitted the documents in physical mode as on 31.10.2022. The remaining Homebuyers are advised to submit their complete set of documents at the earliest.
- (iii) The Homebuyers should submit the following documents in physical form either through Registered Posts/ Courier/ or in person to the **Commercial Accounts Division** to the officer mentioned in para 2(i) above.
 - (a) Advance Receipt (in the format given in **Form-1**) for the Net Amount qua the Residential Unit of the Homebuyer;
 - (b) One cancelled cheque in respect of the Bank Account in which the Homebuyer intends his refund to be electronically transferred;
 - (c) One latest passport size photograph;
 - (d) PAN Card (self-attested copy);
 - (e) Aadhaar Card (self-attested copy);
 - (f) Allotment Letter (original);
 - (g) Builder-buyer Agreement along with the Payment Schedule (in

- original)
- (h) Original Receipts issued by the Company in acknowledgement of payment of dues made by the Homebuyer from time to time; and
 - (i) Registered Will or Succession Certificate in favour of the recipient issued by a Court of competent jurisdiction in the event of death of the original Allottee/ Homebuyer.
 - (j) In case of allotment of a Unit in Joint names, particulars of the bank account(s) in which the refund amount is to be credited along with a letter from the joint allottee to remit the amount to such account or individual account details if the refund is to be made to each of the joint allottees in his/ her bank account.
- (iv) All those Homebuyers **who have availed loans from any Bank/ Financial Institution (FIs)** by mortgaging their respective Residential Units are required to submit an Undertaking in the prescribed **Form-2** (appended herein). They would also be required to submit the following additional documents:
- (a) Bank Statement (duly certified) in respect of the Loan Account indicating the outstanding amount to be paid by the Homebuyer(s);
 - (b) Tripartite Agreement (original copies of the tripartite agreement pertaining to the Homebuyer and the Banks/ FIs); and
 - (c) Permission to Mortgage granted by the Company in favour of the Homebuyer prior to availing of loan from the Bank/ FI.
- (v) The disbursement of the amount shall, as directed by the Hon'ble Supreme Court, be subject to the following conditions:
- (a) The full refund once made by the Company to the eligible Homebuyers on the ground of medical exigency shall be considered as being so made "in full and final satisfaction of their claims";
 - (b) There shall be refund only of the Principal amount and no claim of interest on Principal amount would henceforth survive and they shall have no claim of any nature against the Unitech Group in future;
 - (c) Apartment/ Units/ Plots etc. which were allotted to them against their deposits shall henceforth form a part of the unsold inventory of Unitech Group; and
 - (d) In those cases where the Homebuyers have taken loans from Banks or Financial Institutions, the disbursement shall be made directly to the concerned Banks/ Financial Institutions, upon which the lien on the Units which have been sold shall stand released. Any balance that remains after satisfying the claim of the Banks/ Financial Institutions shall be paid over to the Homebuyers.

- (vi) If any Homebuyer does not come forward for completing the formalities as directed by the Hon'ble Supreme Court and as outlined herein, he shall be afforded one additional opportunity, failing which the names of such non-responsive Homebuyers shall be submitted to the Hon'ble Supreme Court.
