contemplating to launch a new party for which he is in talks with friends and supporters," the Raiya Sabha MP's close aide Vijay Verma told reporters in Madhepura on Wednesday. He also ruled out the possibility of Sharad joining the Union cabinet. Soon after Nitish's realignment with the NDA last

Wednesday, Sharad met opposition leaders, including CPM's Sitaram Yechury, CPI's D Raja, Congress veteran Ghulam Nabi Azad and RLD's Ajit Singh. Sharad said that the 2015 Bihar mandate was not in favour of Nitish's alliance with the NDA. He termed the disintegration of the Grand Alliance as "unpleasant and unfortunate". JDU secretary general K C Tyagi, however, claimed that Sharad was unlikely to float a political party. "We are aware of his dissent. He had differences with Nitish Kumar in the past as well, including on the issue of demonetisation," Tyagi said. Sharad remains the founder-president of the JDU and commands respect in the party, he said. "We have invited him to the party's national executive meet in Patna on August 19," Tyagi added. RJD chief Lalu Prasad, too, is trying to woo Sharad.

'India's silence on Maldivian issue will worsen crisis'

New Delhi: With the army taking control of the Maldives' parliament, the sound of India's silence is becoming increasingly unbearable for the unified Maldivian opposition. In an exclusive interaction with TOI, former president Mohamed Nasheed and top leader of the fourparty joint opposition said that the silence of regional powers wiil allow the chaos in the archipelago to worsen, throwing the region into disarray.

"It is worrying that, even when red lines are crossed, regional powers remain silent and inactive because that can allow the chaos and conflict to spiral out of control," Nash-Nasheed eed told TOI. "The Maldives is in full blown political cri-

sis. President Yameen's troops continue to occupy parliament, forcibly evicting opposition MPs and preventing the legislature from functioning," he added.

Constrained by strategic objectives, not least the presence of China which is now said to account for 70% of the Maldives' external debt, India has found it difficult to sound excessively critical of Yameen whose government stands accused of subverting democratic institutions in the country

Ironically, in their attempts to get India to ensure free and fair elections, which are due next year, Nasheed's Maldivian Democratic Party (MDP) and others have often sought to play on India's fear of growing Chinese influence in Maldives. "Yameen no longer even pretends to respect the law or the Constitution. He turns a blind eye to Islamic radicalism and entertains partnerships that undermine Indian Ocean stability," said Nasheed.

The joint opposition is worried that India's reaction until now has been limited to what it sees as a wishy-washy response to a query on Maldives in a routine ministry of external affairs

briefing. "Maldives is very important neighbour of ours. It is part of SAARC We attach the highest importance to our relations with Maldives. India wishes to see a stable, prosperous and peaceful Maldives in which aspirations of

people of Maldives are fulfilled," the spokesperson had said in response to a media query.

In stark contrast to India's silence, countries like US and UK have spoken out against the attempts to impede the functioning parliament in the country. Maidives remains the only country in India's neighbourhood which is yet to see a visit by PM Modi. The present crisis in the Maldives was brought about by Yameen's decision to deploy troops in parliament, People's Majlis, in an attempt to deny the opposition a no-confidence motion it had sought against the Speaker, who is described by the MDP as a Yameen crony.

Had 'notified' India about Doklam road project: China

ut brushing all this aside, Indian sources stressed China had unilaterally broken the status quo by trying to construct a motorable road in the Doklam area, which was physically blocked by Indian troops on June 18. They said this violated the 2012 pact between their two special representatives that the trijunction boundary points would be finalised in consultation with Bhutan.

The lengthy Chinese state ment seemed to be an attempt to assuage hawkish sentiments at home and prepare the ground for what will eventually be a mutual troop withdrawal, while also trying to sell to the international community that India was the real aggressor in the Doklam dispute. "India, in fact, came to Bhutan's aid to prevent China from bullying the tiny country," said a source.

Around 300-350 Indian troops, with two bulldozers, continue to maintain their "non-aggressive" vigil at the actual face-off site in the Doklam area, which is located at an altitude of over 11,000 feet. "There has been no troop reduction by India on the ground. Around the same number of PLA troops are present at the face-off site. Both sides have pitched tents at a distance of 120-150 meters from each other across the Torsa Nala. But there is no gun-pointing or animosity between the rival troops," the source said.

Hollongi, not Tawang, to get Arunachal airport

mid deteriorating Sino-Indian ties, this is one news that may soothe frayed nerves. The Arunachal Pradesh government and Union aviation ministry have zeroed in on Hollongi as the site for a greenfield airport. Earlier the government was examining Tawang -very close to Tibet (China) - as a possible site for the new airport but due to paucity of land needed for the project, Hollongi has been selected. "The state government of Arunachal and a panel of aviation ministry has chosen Hollongi as the site for a new Greenfield airportAAI chairman Guruprsdad Mohapatra told TOI. "Tawang was a very hilly site. Clearing a site for an airport there would have meant cutting-and-filling hills which would have had a Saurabh Sinha TN high cost," said an official.

Apart from the over 6,000 soldiers already deployed under two formations (63 and 112 Brigades) in east and northeast Sikkim, the Indian Army has also moved up another 2,500 soldiers from the 164 Brigade to Zuluk and Nathang Valley in the state as reinforcements, as was first reported by TOI.

The Chinese foreign ministry, on its part, claimed Beijing had "notified India in advance in full reflection of China's goodwill" before it started the road building activity on June 16. But Beijing also seemed to be changing tack by saying the dispute was between China and Bhutan, and India had nothing to do with it. It had earlier projected the Doklam issue as an India-China tussle to avoid being accused of grabbing territory from a small country.

"The China-Bhutan boundary issue is one between China and Bhutan. It has nothing to do with India. As a third party, India has no right to interfere in or impede the boundary talks between China and Bhutan, still less the right b make territorial claims of Bhutan's behalf," it said.

China took the rare ste of using a non-paper (a dis cussion paper, not a forma agreement) of the May 200 India-China boundary talk as proof that the two cour tries had already agreed to border alignment in the Sil kim region. In doing so, sai sources, Beijing may have v olated the principle of secre cy by making public a sens tive issue pertaining to th negotiatior. among special represent: tives of the two countries.

The Chinese ministr said, "The fact of the matter that it is India which has a tempted time and again 1 change the status quo of th China-India boundary in th Sikkim sector, which poses grave security threat to Ch na." 

He stated that constructing dams upstream will increase the salinity in the rivers of the state and also ecologically affect the areas up to the Western Ghats.

"This is an ecological bomb that Karnataka is planting in the form of dams," the chief minister told the House.

He claimed thatthe Goa government has designed certain strategies to tackle the water dispute, Parrikar refused to reveal them in public.

No plan to set up collegium to select election commissioners: Govt

NEW DELHI, 2 AUGUST

The government on Wednesday said it has no proposal to introduce a 'collegium' system to appoint election commissioners, a recommendation made by the Law Commission aspart of its report on electoral reforms.

Italso said that it has no plans as of now to draft a law on selecting the chief election commissioner as well as fellow election commissioners.

"No madam," said Minister of state for Law PP Chaudhary in the Lok Sabha in a written reply to a question on whether there was a proposal to introduce a collegium system as part of a selection process to appoint election commissioners in future.

"At present, no such proposal is under consideration of the union government," the minister said to a question on whether the Centre will seek the advice of all parties before drafting a law on the selection process of CEC and fellow ECs.

In its March 2015 report on electoral reforms, the law panel had recommended that the appointment of all election commissioners, including the CEC, should be made by the President in consultation with a three-member collegium or selection committee, consisting of the Prime Minister, the Leader of the Opposition of the Lok Sabha (or the leader of the largest opposition party in the
