### C. Uniworld Resorts Plots, Sector-33 & 48, Gurugram (Date of E-Auction – 30.01.2026)

Uniworld Resorts is a premium Residential Plotted Colony, being developed over 136.446 acres in Sector-33 & 48, Gurugram. Uniworld Resorts Plotted Colony has a mini Golf Course and residential components like Villas, Plots and Apartments in Multi-storeyed Group Housing Complex, apart from a fully established independent Commercial Complex. ### D. Common Terms & Conditions

- (i) All the Plots / Apartments / Independent Floors / Commercial Units will be allotted on **Free-hold basis (as is where is)** and are part of the approved lay-out plan of the concerned Colony.
- (ii) All Projects of Unitech Group, under development, are exempted from registration under RERA, vide Order dated 16.01.2025 of the Hon'ble Supreme Court of India.
- (iii) The allotment of all the Residential/ Commercial Units offered for Sale will be carried out through **category-wise computerized E-Auction**.
- (iv) In the E-Auction, the Minimum Bid Factor for Plots has been kept as Rs. 2,000/- per sq. yard and Rs. 200/- per sq. ft. for the Built-up units (Apartment/ Floors/ Commercial units)

### E. Payment Terms

The following **Payment Terms** will be applicable for the allotment of the Units ready for offer of possession within 30 days from the date of E-Auction in South City-I, South City-II, Nirvana Country, Uniworld Resorts Colonies in Gurugram:

- (i) Payment Terms for Built-up Properties (Apartment/ Floor/ Commercial Unit) in Gurugram
  - Specified EMD along with registration for participation in E-Auction.
  - 30% of the bid value within 30 days from date of allotment (incl. EMD), on issuance of Provisional Allotment Letter.
  - Balance 70% within 90 days from the date of allotment or on offer of possession, whichever is earlier.
- (ii) Payment Terms for Plots in Gurugram
  - Specified EMD along with registration for participation in E-Auction.
  - 30% of the total price within 30 days from date of allotment (incl. EMD), on issuance of Provisional Allotment Letter.
  - 30% within 90 days from the date of allotment.
  - 30% within 120 days from the date of allotment.
  - 10% within 30 days from the date of offer of possession.
- (iii) In case a successful Bidder/ Allottee backs out / wants to withdraw his application within 7 days of the E-Auction, the entire EMD will be forfeited. In such a case, the Second highest bidder may be given an option to acquire the property at the highest bid received.
- (iv) Where a successful allottee does not deposit the first instalment of 30% within 30 days of allotment, the allotment shall be cancelled without any further notice with forfeiture of the EMD.
- (v) In case the subsequent instalments are not paid even within 30 days beyond the scheduled payment dates, the allotment shall automatically stand cancelled and the EMD will be forfeited, without any further notice or communication to this effect.
