- 1 Learned counsel appearing on behalf of the applicant states that the name of the applicant has already been included in the web portal (Portal ID 10679).
- 2 In view of the above position, it has been stated that the purpose of the interlocutory application has been fulfilled and no further direction is sought.
- 3 The Interlocutory Application is disposed of.

Affidavit on behalf of the State of Maharashtra in IA No 135050 of 2021

- An affidavit has been filed by the Superintendent of Mumbai Central Prison in response to the request of the petitioners for being granted video conferencing facilities from the Mumbai Central Prison and from the Taloja Jail with their lawyers in Delhi. The affidavit has explained the reasons why such a facility cannot be granted by making an exception in the case of the petitioners. The affidavit also states that as a matter of fact, 27 physical meetings have taken place with the advocates till 15 March 2022.
- We are unable to make any exception in the case of the petitioners. Hence, in modification of the order dated 10 February 2022, we direct that the facility of meeting the advocates within the premises of the jail shall be allowed in terms of the provisions of the Jail Manual.
- Pursuant to the request of Mr Siddhartha Dave, learned senior counsel appearing on behalf of the petitioners, the Court has been assured by Mr Rahul Chitnis, Chief Standing Counsel for the State of Maharashtra that facilities as are permissible to under-trials in the jail premises shall be allowed in terms of the Jail Manual.
