UPON hearing the counsel the Court made the following O R D E R

In pursuance of the previous order, Mr. Sameer Paranjape of M/s. Grant Thornton has made submissions before this Court. Mr. Paranjape explains that the position in regard to the forensic audit is as follows:

- (i) 80% of the financial and operational records have been made available to the forensic auditors. Mr. Pinaki Misra, learned senior counsel appearing with Mr. Abhimanyu Bhandari, states that the balance shall be made available to the forensic auditors within one week from today;
- (ii) The auditors were apprised initially that for 74 projects of UNITECH, there were 249 bank accounts. Of these, bank statements for 240 accounts have been received by the forensic auditors. However, it emerges that the moneys in 80% of the above bank accounts have been further transferred to another 100 accounts. A requisition has been made by the forensic auditors for

bank statements for all the above accounts. Mr. Pinaki Misra, learned senior counsel appearing with Mr. Abhimanyu Bhandari, states that the bank statements of all accounts shall be made available to the forensic auditors within a period of two weeks from today;

(iii) As regards forensic imaging of the electronic records of Directors and former officers, it has been stated that the work has been initiated and steps are being taken to contact the erstwhile CFOs of the company to retrieve all the electronic records.

We direct that the statements which have been made on behalf of the UNITECH be positively complied with within the time schedule, as indicated above. With reference to (iii) above, erstwhile CFOs shall cooperate with the auditors and make over all the data required. Any breach will be seriously viewed.

The learned amicus curiae has stated, in his status report, that M/s. Grant Thornton have submitted their invoice for professional fees due and payable on account of the work for valuation in connection with the Term Sheet Agreement which was entered into between UNITECH and Sterling & Wilson Pvt. Ltd. The amount is directed to be released to M/s Grant Thornton towards their professional fees of Rs 20,54,675 (inclusive of GST). This amount shall be released from the interest accrued on the FDs with the Registry of this Court. The amicus curiae is requested to follow up on this so that payments

are made to Grant Thornton.

FD Holders

We have perused the status report of the amicus curiae.

At this stage, we consider it appropriate if the learned amicus curiae furnishes further information to the Court in regard to the details of the FD holders with reference to (i) age; (ii) amounts or value of the fixed deposits.

Ex-employees

Mr. Pinaki Misra, learned senior counsel states that in compliance with the previous order dated 15 February 2019, all relevant data pertaining to the employees of the company as on 1 January 2014 shall be filed by tomorrow. We request the *amicus curiae* to file a comprehensive report in regard to the ex-employees after due consultation with the learned counsel appearing on behalf of the employees in these proceedings.
