The Government-appointed Board of Directors of M/s Unitech Group of Companies announces sale of Free-hold Residential Plots/ Apartments/ Independent Floors/ Commercial Units in the Licensed Residential Plotted/ Group Housing Colonies, being developed in Gurugram, through E-Auction mode, as mentioned herein below. ## A. Uniworld Resorts Plots, Sector-33, Gurugram

Uniworld Resorts is a premium Residential Plotted Colony, being developed over 136.446 acres in Sector-33 & 48, Gurugram. Uniworld Resorts Plotted Colony has a mini Golf Course and residential components like Villas, Plots and Apartments in Multi-storeyed Group Housing Complex, apart from a fully established independent Commercial Complex. The Colony is ideally located just adjacent to the operational IT & ITES Hub (SEZ) in Sector-33, Gurugram and is partially occupied, having an excellent connectivity from Sohna Road and National Highway-48 through Hero Honda Chowk, Gurugram.

Licenses to develop the Uniworld Resorts Residential Plotted Colony over 136.446 acres of land were granted by the Town & Country Planning Department, Haryana, vide No. 62-76 of 1998, 992 of 2006, 99 of 2008 & 92 of 2008. All the requisite statutory approvals including Service Plan Estimates etc. are already in place and Part Completion Certificate has been granted by the Competent Authority on completion of development works on an area admeasuring 72.23 acres, apart from Occupation Certificates granted for 65 Villas, 592 Apartments constructed and handed over to the respective allottees in the Group Housing Complex known as 'The Residences' falling within the Plotted Colony apart from 232 Built-up EWS units constructed within the Group Housing Complex.

## B. Commercial Office Complex - Unitech House (Business Floors), Block-L, South City-I, Sector-40, Gurugram

South City-I is a premium Residential Plotted Colony developed in Sectors - 30, 40, 41, Gurugram, by M/s Unitech Limited on land admeasuring 301.43 acres. The Colony has been fully developed and handed over to the Municipal Corporation, Gurugram (MCG) in 2020. The Commercial Complex - Unitech House (earlier known as Business Floors) was developed in the year 1997 and Occupation Certificate of the building was obtained on 21.08.1998.

## C. South City-II Phase-I and Nirvana Country, Sector - 49 & 50, Gurugram

South City-II Phase-I and South City-II Phase-II (Nirvana Country) are premium properties and fully developed Residential Plotted Colonies established in Sectors - 47, 49, 50, Gurugram, by M/s Unitech Limited in Joint Venture Partnership with M/s Pioneer Urban Land & Infrastructure Limited. Both Colonies, spanning around 500 acres of land, are a part of fully developed Sectors - 49 & 50, Gurugram and have been handed over to the Municipal Corporation, Gurugram (MCG) on completion of all the development activities.

Occupation Certificates have already been obtained for the Built-up Units and Part Completion Certificate for the Plot being offered for sale. Currently, both the Colonies are maintained by the MCG and the respective RWAs since September, 2020.

Interested parties can participate in the E-Auction against each of the properties by depositing the EMD prescribed above, which will be refunded to the unsuccessful candidates, without any interest, within 10 working days from the date of E-Auction. Units are almost ready with Occupation Certificates and Possession of the units can be handed over within 30 days on deposit of the Full and Final payment against the units.

#### D. Common Terms & Conditions

- (i) All the Plots / Apartments / Independent Floors / Commercial Units will be allotted on **Free-hold basis** and are part of approved lay-out plan of the concerned Colony.
- (ii) All Projects of Unitech Group, under development, are exempted from registration under RERA, vide Order dated 16.01.2025 of the Hon'ble Supreme Court of India.
- (iii) The allotment of all the Residential/ Commercial Units offered for Sale will be carried out through category-wise computerized E-Auction.
- (iv) The submission of EMD for participation in E-auction opens on 17.11.2025 (11.00 AM) and closes on 15.12.2025 (05.00 PM). The E-auction opens on 18.12.2025 (11:00 AM) and closes on 18.12.2025 (05:00 PM). During this period Bidder can participate by submitting their bids. Bidders can also resubmit their revised bids during this duration.

- (v) In case the units put to E-auction does not receive any bid the Unitech can withdraw the said property from that E-auction without any notice and EMD deposited by the bidders will be refunded.
- (vi) Interested Parties are required to visit the Company's website <a href="www.unitechgroup.com">www.unitechgroup.com</a> for detailed information and follow the process described therein.
- (vii) Separate 'on-line' registrations are to be done against each category of Units for each location, along with refundable EMD, as mentioned above.
- (viii) The actual size of Units may slightly vary in each category and the final payment will be made/ adjusted as per the actual Plot area/ Super Area of the built-up units as per approved Zoning Plan/ Building Plans.
- (ix) EMDs of unsuccessful Applicants will be refunded without any interest within 10 working days from the date of E-Auction.
- (x) Plot being put up for sale is also uploaded on the website, duly marked, on the approved layout plan.

#### E. Payment Terms

- (i) The following Payment Terms will be applicable for the allotment of the Units ready for offer of possession within 30 days from the date of E-Auction in South City-I, South City-II, Nirvana Country, Uniworld Resorts Colonies in Gurugram:
  - (a) Specified EMD (approx. 2 to 5%) along with registration for participation in E-auction.
  - (b) 30% of the Total Price within 30 days from the date of allotment, including EMD, on issuance of Allotment Letter.
  - (c) Balance 70% within 90 days from the date of allotment on offer of possession.
- (ii) In case a successful allottee wants to withdraw his application, he can do so within 7 days of the E-Auction, subject to forfeiture of 25% of the EMD.
- (iii) Where a successful allottee does not deposit the first instalment of 30% within 30 days of allotment, the allotment shall be cancelled with forfeiture of the EMD.
- (iv) In case the instalments are not paid even within 30 days, the allotment shall automatically stand cancelled and the EMD will be forfeited, without any further notice or communication to this effect. Balance amount deposited, if any, will be refunded without any interest within 30 days from the date of cancellation.
- (v) Physical Possession of the Plot/ Unit will be handed over only after payment of all the dues by the Allottee.
- (vi) The Conveyance Deeds will be executed on completion of the conditions/ formalities as mentioned in the Offer of Possession Document, for which the Allottee will have to pay the Stamp Duty and registration charges, as applicable.
- (vii) Reserve Price excludes Interest Free Maintenance Security (IFMS) (If Applicable), Club Membership Fees) (If Applicable), and the amount, which is payable on account of Stamp Duty and Registration Charges.
- (viii) Third Party Transfers will be allowed on the request of the allottee only after depositing initial 30% payment against the price of the Unit and on payment of the applicable transfer charges.

- (ii) After the successful registration, the intending bidders are required to deposit the Earnest Money (EMD) against the properties for participation in the auction by generating the E-Challan after logging into the E-Auction portal by using the User ID and Password. Payment has to be made through NEFT / RTGS as per the details mentioned in the E-Challan.
